# ORDINANCE NUMBER 2011-02ORD Spring Valley Park Regulations

AN ORDINANCE OF CLINTON TOWNSHIP, BUTLER COUNTY, PENNSYLVANIA PROVIDING FOR CLINTON TOWNSHIP BOARD OF SUPERVISORS TO, FROM TIME TO TIME BY RESOLUTION, ESTABLISH RULES AND REGULATIONS FOR THE SPRING VALLEY PARK, CLINTON TOWNSHIP, PA

WHEREAS, Clinton Township Board of Supervisors seeks to establish rules and regulations for the Spring Valley Park; and

WHEREAS, Clinton township Board of Supervisors seeks the flexibility of revision of rules and regulations as may be from time to time required; and

WHEREAS, Clinton Township Board of Supervisors seeks to be able to enforce the rules and regulations pursuant to the provisions of the Second Class Township Code, as from time to time amended, pertaining to ordinance enforcement.

NOW, THEREFORE, it is hereby ordained and enacted as follows:

## 101. PURPOSE

The purpose of this Ordinance is to provide for the establishment of rules and regulations for the use and conduct of activity within Spring Valley Park, so as to provide a safe, healthy and orderly use of the park and its facilities.

## 102. RULES AND REGULATIONS

Clinton Township Board of Supervisors shall, from time to time by Resolution, establish and/or amend rules and regulations for the use and conduct of Spring Valley Park.

#### 103. ENFORCEMENT

The rules and regulations established by Resolution of the Clinton Township Board of Supervisors may be enforced by any law enforcement agency and/or any duly authorized representative of Clinton Township who is charged with the administration and enforcement of this Ordinance.

## 104. VIOLATIONS AND PENALTIES

Violation of this Ordinance is a summary criminal offense. Any person, firm or corporation violating any provision of this Ordinance shall be fined not less than One Hundred Dollars (\$100.00) nor more than Six Hundred Dollars (\$600.00), plus attorney fees and costs and the actual cost for restitution in the event of any damage to park property.

## 105. SEVERABILITY

If any section or part thereof, sentence, clause or phrase of this Ordinance shall be held to be unconstitutional or invalid, the remaining provisions thereof shall, nevertheless, remain in full force and effect.

## 106. REPEALER

This Ordinance shall not act to repeal the Clinton Township Codification of Ordinances, in whole or in part, except to the specific extent set forth above.

## 107. EFFECTIVE DATE

This Ordinance shall become effective five (5) days after enactment.
