- Planning Commission-Kathy Allen
 - ✓ Allen reported the Planning Commission met on 11.2.2020. Allen also said the Board of Supervisors appointed Brian Snyder to the Planning Commission to replace David Koren and also appointed two alternates Dave McRoberts and Marty Micko.

- Champion Waterproofing
 - ✓ Not resolved-still outstanding
 - ✓ The Township Solicitor is now handling this situation.
- Victory Road Warehouse follow-up-1200 South Noah Drive
 - ✓ Working with HRG-
 - Sent invoice for TDRs
 - Waiting on performance bond-Craig Bishop stated this may take a bit longer. Craig Bishop from HRG updated the Township on 10.21.2020, he stated they are reviewing the Estimate Probable Costs to issue the Performance Bond.
 - SunCap is holding off on paying the TDR's until their financing is in place.
- John Allen III and Andy Allen's Property-1046 Ekastown Road
 - ✓ Moved to the Zoning Hearing Board
 - ✓ Zoning Board Hearing is scheduled for October 27, 2020 at 6:30 pm
- Sewer Authority
 - ✓ Installing a new sewer line along Tower Rd
 - ✓ In October, the Sewer Authority started trimming trees along Tower Road
 - ✓ Cronin Enterprises have applied for their Excess Maintenance Agreement with a Bond. We are only waiting for the Supervisors to sign and then it is completed.

 - ✓ Cease and Desist
 - The Cease and Desist order for 425-427 Freeport St. is still in effect and the Board of Supervisors is seeking council from our solicitor. The Supervisors and Code Enforcement Officer are meeting with the property owners on 10.30.2020.
 - A Cease and Desist order was issued for 429 Freeport St. The Criswell Residence for having a Home Occupation without a permit. Harigan, the Code Enforcement Officer, reported that Mr. Criswell called and stated this was a Hobby not a Business. Harigan asked for a written and signed letter stating it was a hobby. The township has not yet received the letter.

 - Hartwig is reviewing, with Pitell Construction on a Stormwater Management Plan.
 - Hartwig asked Harigan to send a letter to the HOA of the Plantation with copies of the agreement, that states the Plantation is to maintain the Retention Pond. He also stated that no stormwater grates will be required on the driveway.
 - Updates on Todd McCurdy, representing the HOA of the Plantation, recognized receipt of the letter and is going to present it at their next meeting.

 - ✓ Hartwig review the Bids and passed out a letter to the Board of Supervisors to proposal the Supervisors award the bid James D Miller and Sons Construction Inc. the lower bidder.
