ROAD DEPARTMENT

ROAD REPORT MARCH 8, 2021

BY: LUKE BREWER, ROAD FOREMAN AND TOM HARTWIG, ROAD MASTER FACILITIES AND EQUIPMENT

- JD Miller & Sons Construction has completed all construction work on the new building with the exception of the exterior shutters. We are in a position now to release the Performance and Payment Bonds.
- The Road Department has been working on sealing the new public works building floor.
- With the loss of trucks and other equipment in the February 21st fire, Cranberry Twp, Middlesex Twp, and Winfield Twp have assisted us by supplying Trucks and Equipment for our use.
- Assistance has been given to various Selective Insurance Adjusters and Investigators who have been out to view the garage, trucks, and the equipment impacted by the fire.
- In dealing with the Selective Insurance Equipment and Tool Adjuster, we prepared a detailed item list has been made for the tools and supplies that got damaged or destroyed in the fire.
- Murphy Tractor is letting use a new John Deere wheel loader on a trial basis. We also intend to try other companies' wheel loaders.
- We are obtaining prices from various dealers on all the equipment and trucks we lost in the fire.
- We did order a new Peterbilt 10 Ton Dump Truck essentially to replace the one we just lost in the fire.
- The Hosty Pressure Washer was sent to Mars to get serviced and worked on. We had concerns about the electrical wiring for the unit.

ROADS

- The tar and chip project was significantly downsized and with PennDOT's assistance advertised for bids again.
- Shields Asphalt and Paving was awarded the bid for Coal Hollow Rd. A letter was sent to Shields notifying them and informing them of a preconstruction meeting, full time inspector from the Township, and the Township's plan to sample the material put down on the road for conformance with the specifications.
- The PW team has cleaned catch basins and cross pipes throughout the township and patched many potholes on Township roads.
- The Butler County Bridge Crew called to notify the Township that Brewer and Wylie bridge were award to Merlo Inc on January 21st, 2021. The Bridge replacement for both is to be done this summer.
- The PW crew has been picking trash and garbage up on Stark Rd, Tower Rd, and the Roundabout.
- The PW crew has made and marked Pa. One Calls for speed limit and weight limit signs scheduled to be installed on Knoch, Brewer, Westminster, and Sun Mine Roads.
- Township Line signs and Private Lane signs have been installed throughout the Township.
- We are getting multiple prices for tree removal and tree trimming on Coal Hollow Rd.

WINTER MAINTENANCE

• There were 18 call outs in the month of February to salt and plow the roads. The PW crew has done an excellent job keeping our roads passable and safe during snow and ice events.

- The PW team washed and waxed all the trucks after each time out in the snow.
- The Township ordered 480 tons of salt from Detroit Salt Company.

MISCELLANEOUS

- The Township ordered 300 Gallons of Diesel Fuel, and 100 Gallons of Gasoline from Purvis Brothers.
- The crew removed a tree that fell across Wylie Road on March 1st.
- On March 2nd, the PW crew worked with West Penn Power and Lewis Tree service to remove two trees on Coal Hollow Road that were hanging over the main transmission line on Route 228.
- New signs were ordered for the gate to the Public Works garage area that indicate that no visitors are permitted beyond the gate. Visitors should check in with the Township office or be scheduled with the Road Foreman in advance of arrival.
- Cones were placed along Saxonburg Boulevard to try to deter visitors from entering the parking lot to view our loss. Stray traffic and sightseers have been an issue since the fire, even large trucks
