The motion was seconded by Supervisor James Halstead. The motion carried unanimously.

- Park Committee by liaison Jim Halstead: Supervisor James Halstead reported that the Park Board will be having their meeting tonight at the park.
- Planning Commission by liaison Kathy Allen: Chairperson Kathy Allen reported the Planning Commission's next meeting is scheduled for June 6, 2022 at 7:00PM

#### **CORRESPONDENCE:**

#### **SOLICITOR'S REPORT:**

- Solicitor Sarah Hancher reported that she prepared a letter for Northwest Bank to change the signatures on file. The three supervisors will remain signers on the accounts. Ashley Kohley, who was appointed Treasurer at the May 16, 2022, Special Meeting, will be added as a check signer. Mrs. Kohley is already bonded with the Township.
- Solicitor Sarah Hancher reported on open Code Enforcement Activity. A certified letter was sent to 416 Sunmine Road regarding the disabled motor vehicles on Sun Mine Road. Should the property owner fail to comply with the timelines stated in the letter, the matter will proceed through the court system.

## **DIRECTOR'S REPORT:**

- Public Works Garage Construction Status: Director Ashley Kohley reported that the final occupancy certificate has been issued and the boiler certificate has been received.
- J. D. Miller and Sons Construction Change Order No. 4: Director Ashley Kohley reported that she needs approval from the Board of Supervisors for Change Order No. 4, before sending it back to J.D. Miller and Sons Construction.
- Permits and Code Enforcement: Director Ashley Kohley reported the pool and hot tub permits have been requested at the Township. Mrs. Kohley is working with MDIA through the permitting processes. Peoples Gas applied for a road occupancy permit for old Saxonburg Boulevard. Road Foreman Luke Brewer has been notified and will provide the inspections for Peoples Gas.

Vice-Chairman William Duncan made a motion to approve Change Order No. 4 submitted by J.D. Miller and Sons Construction in the credit amount of \$1,5042.90 to the contract with the Township for construction of the new Public Works Garage. A second was made by Supervisor James Halstead. The motion carried unanimously
