CALL TO ORDER: Chairperson Kathy Allen called the meeting to order at 7:02 PM with the Pledge of Allegiance.

EXECUTIVE SESSION:

Chairperson Kathy Allen called an executive session to discuss litigation matters. The executive session was over at approximately 7:12 and the regular meeting was resumed.

Kathy Allen asked for a motion to add the Bochek/Crisswell Lot Line Revision to New Business to be considered for approval. The motion was made by Vice-Chairperson William Duncan to add the Bockek/Crisswell Plan to the Agenda under New Business. The motion was seconded by Supervisor Jason Davidek. The motion passed unanimously.

- Spring Valley Park: Liaison William Duncan asked to speak under New Business regarding the Resolution for the Park Grant.
- Planning Commission by Liaison Kathy Allen. Mrs. Allen stated that the Planning Commission has a non-voting meeting scheduled for February 26, 2024 if needed and a Regular voting meeting with workshop scheduled for March 4, 2024. Director Ashley Kohley provided the draft minutes from the last PC meeting for the board to review. Work will continue on the Comprehensive Plan updates through workshop dates. Mrs. Allen also reported that the Planning Commission is looking for applicants to join the board. Currently they have 6 sitting members and need an additional sitting member as well as alternates to join the board. The applications can be provided in the office or on the township website.
- History Committee by Kathy Allen- The history committee is meeting February 15, 2024 at the Clinton Township Municipal Building. The topic includes interviewing Bruce Kennedy and discussing the one room schoolhouses that were once located in the township.

CORRESPONDENCE:

SOLICITOR'S REPORT:

Solicitor John Bench stated that the Victory Road Owner's Association has declined to grant an easement to bring electric to POD 4 of Spring Valley Park. He will be filing a declaration of taking for the easement required.

DIRECTOR'S REPORT:

- Building Permits- Director Ashley Kohley reported to the board that there was one new single family home permit, one Ag building with driveway permit, and one porch roof addition permit for the year so far.
- Updated Budget- Director Ashley Kohley provided a YTD QuickBooks budget for the board to review.
- BCATO Spring Convention will be held May 16, 2024 at Country Club- Director Ashley Kohley gave the board an update on the Butler County Association of Township Officials meetings.

CODE ENFORCEMENT OFFICER REPORT:

Code Enforcement Officer Clinton Bonetti issued two letters since the last meeting. One letter addressing construction without permits and another regarding garbage and disabled vehicles. An appeal was made in regard to a side yard setback a zoning hearing will be scheduled in the near future.

• Road Report (Facilities and Equipment) – Road Foreman Luke Brewer gave the road report to the board. The road report will be attached to the approved minutes.

Victory Road Bridge Deck Replacement, Jason Snyder of PennDOT

A motion was made by Vice- Chairperson William Duncan to hire Jason Snyder of PennDOT to oversee the Victory Road bridge deck replacement project with the assistance of the Township Engineer (Redcon Engineering). The motion was seconded by Supervisor Jason Davidek. The motion passed unanimously.

Resolution 2024-02- Non-Working Supervisor Compensation

Resolution 2024-03- Spring Valley Park Grant

A motion was made by Vice- Chairperson William Duncan to adopt Resolution 2024-03 Butler County Parks Renovation/Development Grant Program in which Clinton Township of Butler County desires to renovate the Spring Valley Park for public use in accordance with the current accepted standards. The motion was seconded by Supervisor Jason Davidek. The motion passed unanimously.

• Bochek/Crisswell Plan- Lot Line Revision to convey Tract A (1.8) from parcel 2D to parcel 2DA. Parcel 2D, shown as Lot 2R, will be 14.82 acres which is vacant and has previously been approved for an on lot septic system. Parcel 2DA will be 5 acres and has a single-family residential dwelling.

A motion was made by Vice-Chairperson William Duncan to approve the Bockek/Crisswell Plan. The motion was seconded by Supervisor Jason Davidek. The motion passed unanimously.

ROAD DEPARTMENT REPORT February 14th, 2024 BOARD OF SUPERVISORS' REGULAR MEETING

FACILITIES AND EQUIPMENT

- Continued routine maintenance on the trucks and equipment, including washing and cleaning.
- Changed the Bristles on the Pull Behind Broom and the Broom for the Skid loader.
- Peterbilt #1 and Peterbilt #2 had the Cameras installed in the bed and on the back of the trucks. This was installed by the U.S Municipal.
- 2016 Ford F550 and 2020 Ford F550 got inspected at Crystal Truck and Auto. 2016 needed a tie rod end replaced.
- Graff Surveying marked out the rest of the township's property. The road crew installed markers to mark the post and put up no hunting and trespassing signs.
- All the equipment has been serviced and got a full preventive maintenance.
- Received price quotes on the 2024 Pipe project so far, the cheapest was Interstate Pipe in Butler.
- The Traffic counter is still getting moved around the township roads.

ROADS

- The township has been out Tree Trimming the Roads. The roads that have been trimmed so far are Cannon Hill Rd, Christy Rd, Tower Rd, and Timber Ridge Road.
- February 13th had a Non-Mandatory Pre-Bid Meeting regarding Jack Rd Project.
- Received a price quote from Falling Timber for Cherry Valley Rd to finish the rest of the tree trimming on that road.
- From Beginning of January to Date the Township was out 11 times to salt the roads. We have ordered to date 366 ton of salt and used a total of about 200 tons of salt to date.
- Sarver Rd is being monitored. For the work that Toy Pipeline is doing for Penn Energy. Also, the other roads that Penn energy is doing work on are getting watched also.
- Delineators have been installed throughout the township. Along with clearing catch basins.
- Street signs that were damaged have been replaced and fixed.
- Potholes and Berm repair have been getting done throughout this month.
- PA. One Calls were marked for speed limit, weight limit signs, and other signs throughout the township.
